Guarantee/Contract

Seller guarantees that at the time of delivery, the puppy is in excellent health. All Golden Valley Doodles pups are examined by a Licensed Veterinarian and receive Certified Health Certificates. This includes a fecal on each puppy and a full body exam (ears, eyes, mouth, teeth, heart, etc.) Golden Valley Doodles guarantees that at the time of delivery, the puppy has received proper vaccinations and dewormings appropriate for its age. We also guarantee your puppy to be free from moderate or severe Hip Dysplasia for two years from the puppy's date of birth. We guarantee your puppy to be free from the Parvo virus and Distemper on the puppy's date of delivery.

The Buyer has three (3) days from the time of receipt of puppy to have puppy examined by a Licensed Veterinarian. Any request to return the puppy to the Seller for a replacement puppy must be made within this three day time period. Proof of examination must be provided. Excluded from this condition are the following: treatment for any type of parasite, worm or bacteria, internal or external including but not limited to coccidia and giardia. This warranty will be terminated immediately if dog is not examined within the allotted time.

A warranty against all serious life altering genetic disease is provided until puppy is two years of age. Before age two, if a genetic disease that will greatly shorten the life of, or greatly alter the quality of life of the puppy is discovered, Seller will provide Buyer with a replacement puppy. Minor health ailments including, but not limited to, fleas, worms, or stress induced diarrhea due to the puppy's transition from the Sellers home are not valid reasons. Proof of examination and diagnosis must be provided to Seller and Sellers vet via email within 5 days of diagnosis. Failure to do so will result in the cancellation of the Warranty.

A warranty for moderate to severe Hip Dysplasia is provided to age 2 (two). This warranty will be null and void should dog be allowed to become overweight or developing joints be overstressed at any point during the first two years. Should dog be

diagnosed within its first two years, Buyer must provide Seller with proof in the form of documentation from PennHIP or OFA. Results must be forwarded to Seller via email and US mail (certified, return receipt) within one week of receipt from PennHIP/OFA. Failure to do so will result in the cancellation of the Health Warranty. We reserve the right to confirm the results before a replacement is provided. Veterinary medical records will be required showing the weight of dog and veterinarians assessment of the weight. Should results from OFA / PennHIP indicate that an injury may have occurred that caused or contributed to the issue, no replacement will be provided.

All Golden Valley Doodles' pups are sold as a family companion or service / therapy prospect, with a strict nonbreeding contract. Buyer agrees to spay or neuter this dog by 7 (seven) months of age with a Licensed Veterinarian. Buyer must send proof of desexing to Seller via e-mail or US mail. Upon execution of this contract, Buyer agrees this dog is being sold as a PET and will never be used for breeding. Failure to follow through with the spay/neuter contract as outlined above will terminate the Health Warranty. Buyer will lose ownership of the dog as well as it's offspring. Legal action will be started for the breach in contract. Any legal fees incurred by the Seller to enforce this non-breeding contract are the sole responsibility of the Buyer.

Seller offers a lifetime re-home policy. Buyer agrees to return dog to Seller, or allow Seller to re-home dog/puppy should it become necessary at ANY point during it's life. If the Buyer is no longer able keep the dog for any reason, the Buyer agrees to return dog to the Seller so that we may re-home the dog. Buyer will be responsible for all financial costs associated with the dog's re-homing. If the Buyer re- home's the dog without the Seller's permission, this guarantee will be canceled, null and void. At no time in the dogs life shall s/he ever be turned over to a shelter or rescue group.

Under no circumstances shall the Seller be liable to the Buyer or to any third party for any consequential, incidental or special damages resulting from or in a manner related to the puppy.

Upon execution of this contract all veterinary care and its associated costs are the sole and exclusive Responsibility of the buyer. Buyer agrees to maintain this puppy/dog in good health, provide routine preventative health care including, but not limited to, Vaccinations, Internal and External Parasites, Heartworm prevention and any other preventative medication Vet feels is required. Veterinary records must be provided to breeder if requesting replacement. If any of the above preventative care has not been provided, or is not documented with a Licensed Veterinarian, the health warranty will be void.

FULL AND FINAL AGREEMENT:

Should any of the conditions above be discovered, and all requirements outlined in this document relating to that condition be met, the Seller will provide the Buyer a replacement puppy (but in no case covers shipping costs) thereby resolving the issue. The Seller is not responsible for any costs incurred by the Buyer associated with the treatment or diagnosis of the puppy. All costs associated with the diagnosis and treatment of the puppy is the exclusive responsibility of the Buyer. The Seller does NOT require the Buyer to return the affected dog in the event of an exchange, though the Buyer may return the dog if so desired. Seller reserves the right to confirm any of these results via independent Veterinarian examination before a replacement is given. Results of this Veterinary examination will be the final deciding factor as to whether a replacement will be given.

Both Buyer and Seller agree that this Contract represents the entire Agreement between them and that no other representations have been made regarding the puppy described above. This agreement is between Seller and Buyer only and is not transferrable.
